FIRST NCA NOTIFICATION

Applications are invited online only through One Time Registration scheme from qualified candidates belonging to the Hindu Nadar community in the State of Kerala for selection to the under mentioned post in Kerala Government Service. Before applying for the post the candidates should register as per the One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

1. **Department** : Kerala State Water Transport
2. **Name of Post** : Boat Lascar
3. **Scale of pay** : ₹24,400-55,200/-
4. **Number of vacancies** : Hindu Nadar – 01 (One)

The above vacancy is now in existence. The Ranked list published by the Commission in response to this notification will be valid until candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Hindu Nadar community during the currency of the Mother Ranked List published on 22.02.2017 (Category No.468/12; Gazette date:15.09.2012) or three years from the date of publication of this NCA Ranked List, whichever is earlier.

5. **Method of appointment** : Direct Recruitment (from candidates belonging to Hindu Nadar Community only)

Note :- Applications submitted by candidates other than the community mentioned above will be rejected. No individual rejection memo will be issued.

6. **Age limit** : 19-39. Only candidates born between 02.01.1982 and 01.01.2002 (both dates included) including relaxation in Part II para 2(i) of the General conditions are eligible to apply for the post. [For other conditions regarding age relaxations, please see Part II para (2) of the General Conditions except para 2(i)]
7. **Qualifications:**
 1. Literacy in Malayalam or Tamil or Kannada.
 2. Possession of Current Lascar's Licence

- Note:-**
- 1) Candidates should possess current Lascar's Licence through out all the stages of selection process.
 - 2) Rule 10 a (ii) of part II of KS&SSR is applicable.
 - 3) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
 - 4) In the case of difference in original caste/ community claimed in the application and that entered in the School Admission Register/ SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate at the time of certificate verification.

8. Mode of submitting applications :-

- (a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the printout of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (c) Appropriate disciplinary action as per KPSC Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- (d) “Candidates who have AADHAR Card should add AADHAR as ID Proof in their profile.”
