NOTE: The result of the candidates with serial numbers 297,298, 299, 300, 301, 302, 303, 304, 305, 306, 307, 308, 309, 310, 311, 312, 313, 314, 315, 316, 317, 318, 319, 320, 321 & 322 are provisionally included in the Ranked List as per Interim order OP(KAT) No. 216/2020 and in OP(KAT) No. 243/2020 on 22.07.2020 and 29.07.2020 respectively.
