Applications are invited from qualified Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should bear the name of candidate and the date of photo taken should be in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

1. **Department** : **Kerala Police Service**
2. **Name of Post** : **Sub Inspector of Police**  
(SR for ST only)
3. **Scale of pay** : **₹. 32300-68700/-**
4. **Number of vacancies** : **6 (Six)**

Note: The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year . Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Tribes only during the pendency of the list.

5. **Method of appointment** : **Direct Recruitment**  
**(Special Recruitment for ST only)**

Note:-1. Differently Abled candidates and female candidates are not eligible to apply for the post.

2. Applications received from candidates other than Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. **Age Limit** **20-36** : Only candidates born between **02.01.1985** and **01.01.2001**. (both dates included) are eligible to eligible to apply for this post.

7. **Qualifications :**

- a. **Educational qualification:-** : Graduation

Note :-Achievements in Sports, Military Training and Membership in the NCC shall be desirable.

- Note :**
1. Rule 10(a)(ii) of part II of KS&SSR is applicable
  2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority along with the Gazette Notification for the same at the time of certificate verification.

**b. Physical Qualification** : Must be Physically fit. Candidates should possess minimum physical standards as prescribed below.

1) Height : 160 cm

2) Chest Measurement : 81 cm with minimum expansion of 5cm

(c) Must be certified by a Medical Officer of the Rank of District Medical Officer of the Health Services Department as to his physique and fitness and capacity for outdoor works and as to the visual standards specified below.

**Note:** 1) Each eye must have a full field of vision. Colour Blindness, Squint or any morbid condition of the eye or lid of either eye shall be a disqualification.

2) Candidates shall be free from apparent physical defects like Knock-knee, Flat Feet, Varicose veins, Bow legs, Deformed limbs, irregular and protruding teeth, defective speech and hearing.

(d) Candidates should produce a medical certificate in original at the time of Certificate Verification in the form prescribed here under certifying to their physical fitness and eyesight without glasses obtained from a District Medical officer not below the rank of a Civil Surgeon.

Note: Details regarding standards of vision should be clearly stated in the Certificate, as given above. Vague statements such as vision normal, Average etc. will not be accepted. Specification for each eye should be stated separately against each item.. If the specifications are not as indicated above, the officer issuing the certificate should notify whether the candidate has got better standards of vision or worse standards of vision, as the case may be, otherwise the Certificate will not be accepted.

**(e) Selection Test**

In addition to the qualification prescribed above every candidate will be subjected to a Physical Efficiency Test and must qualify in at least 5 of the undermentioned 8 events for one star std which is the minimum requirements for the recruitment. The Physical Measurement of the candidates will be taken at the time of Physical Efficiency Test and those who do not possess the prescribed Physical Measurements will not be admitted for the Physical Efficiency Test.

Note: If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

**8. Training :-** Every person appointed under this post shall undergo training for a period of 1 year in the Police Training college and Practical Training for 10 ½ months in the district as per syllabus.

**9. Pay during the Training Period :-** During the period of training candidates shall be paid minimum of the scale of pay plus usual allowance attached to the post.

**10. Probation :-** Every person appointed under this rule shall, from the date on which he completes practical training be on probation for a total period of 2 years on duty with in a continuous period of 3 years.

**11. Mode of Submitting application**

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the Photograph uploaded. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application

submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

<b>15</b>	Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
<b>16</b>	If written/OMR/Online Test is conducted as part of the selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
<b>17</b>	As per Rule 22 of the KPSC Rules of Procedure 1976, appropriate disciplinary action will be taken against those candidates who submit application for the post with bogus claims of prescribed qualification, experience etc. and give confirmation for examination
