At 8.00 A.M on the date indicated in the interview schedule hosted on the Commission's website www.psc.ap.gov.in in the **Office of the Andhra Pradesh Public Service Commission, New HOD Buildings, 2nd floor, Opposite Indira Gandhi Muncipal Complex, M.G. Road, Vijayawada-520010**. Interview will be followed subject to eligibility at 11.00 A.M/ 2.30 P.M on the same day.

He /she should produce the following certificates in original and a set of Photostat copies duly Attested by the Gazetted Officer, failing which he /she will not be admitted to the interview.

S.No.	Original Certificates with a set of Photostat copies of the same to be produced.
I.	Date of Birth (SSC or its equivalent) in support of Minimum / Maximum age as on 01/07/2018.
II.	Service Certificate/ Any other certificate in respect of age relaxation claimed.
III.	Integrated Community Certificate (issued by the concerned Tahsildar/M.R.O./R.D.O) for BC, SC, ST Candidates.
IV.	Recent Non-Creamy layer certificate from Revenue authorities for BC candidates only, as per G.O.Ms.No.3, BC Welfare (C2) Dept., dt. 04/04/2006 and G.O.Ms.No.26, BC Welfare (C) Dept., dt.09/12/2013 who claim reservation under BC Community.
V.	Study Certificates from IV class to X class if studied in school or Residence certificate for Private candidates 7 years prior to appearing in SSC.
VI.	Local status certificate in case of candidates who have migrated from Telangana State to Andhra Pradesh State in between 2 nd June,2014 and 1 st June, 2019 as laid out in Circular Memo No.4136/SPF & MC/2015-5, Dated.08/08/2016, 03/09/2016 & 20/11/2017.
VII	Original Qualification Certificates as per qualification Prescribed for the posts as per Notification.No.23/2018 as on 31-12-2018.
VIII.	Relevant certificate of Sports person issued by the Sports authorities shall be produced, for the candidates who claim Sports Quota as per G.O.Rt.No.473 YAT&C Dept.,Dt:03-12-2018
IX	. In case there is any spelling mistake/ mistakes in the Certificates produced by the applicant including the degree certificate, a certificate from the competent authority stating that the original certificates pertaining to him/her are to be produced on the day of verification.
X.	Hall ticket for the Written Examination in original and copy of this memo for verification of Original Certificates.
XI.	Two attestation forms duly filled by the candidate and attested by the Gazetted Officer. The Candidate also directed to affix his/her latest passport size photograph duly attested by a Gazetted Officer on the top of each attestation form.
XII.	Two Check lists duly filled and signed by the candidate.
XIII.	3 Latest Passport Size photos.

i) The above Original Certificates should invariably be produced at the time of verification of Original documents failing which He / She will not be considered for selection process. **“No extension of time for production of any Original certificates will be allowed for the reason whatsoever”** since it was mentioned in the Notification and Hall tickets.

ii) a) If he/she does not submit Study Certificate at the time of verification, he/she will be treated as **non-local**

b) If he/she does not submit Community Certificate/Non Creamy Layer, his/her candidature will be treated as **OC**:

c) If he/she does not submit Degree certificate, his/her candidature will be **rejected**.
