**PUBLISHING OF REVISED FINAL CUT OFF MARKS FOR THE POST OF**  
**FOREST GUARD WITH DRIVING LICENCE**

The Online Examination for the posts of Forest Guard and Forest Guard with Driving Licence were conducted on 08.03.2020 and 16.03.2020. The Online Question Answer Challenge was made available between 07.10.2020 to 10.10.2020. The Questions and Answers that were challenged were considered and the final answer keys were published on 09.11.2020.

2) As mandated, after Normalization of raw score and as per extant Communal Reservation and allied rules, the provisional list of eligible shortlisted candidates for the said post in 1:3 ratio (in order of merit) under each category was published on 24.11.2020. The Certificate Verification and Physical Standards Verification were conducted at Chennai from 05.01.2021 to 07.01.2021 and on 18.01.2021. The Endurance test was conducted at Chennai on 19.01.2021. The list of registration numbers of candidates provisionally selected for appointment by Direct Recruitment to the post of Forest Guard with Driving Licence and the Final cut off mark were published on 24.01.2021

3) Subsequently, the TNFUSRC on 05.02.2021 has issued an erratum to the aforesaid list of candidates provisionally selected for appointment by Direct Recruitment to the post of Forest Guard with Driving Licence and also an additional list of candidate (1No.) provisionally selected for appointment by Direct Recruitment to the post of Forest Guard with Driving Licence.

4) In this regard, the **revised** Communal Reservation wise Final cut off marks for the post of Forest Guard with Driving Licence is given below:
