National Institute of Rural Development & Panchayati Raj (NIRD&PR), Hyderabad, an autonomous national Institution under the Ministry of Rural Development, Govt. of India, is implementing a national level project namely - 'Creating Clusters of Model Gram Panchavats to Achieve Holistic & Sustainable Development through Institutional Strengthening of GPs and Enablement of Quality GPDP across India'. For this, NIRD&PR invitedonline applications candidates Notification from eligible (vide No. NIRDPR/CPRDP&SSD/MoPR-RGSA-ModelGPClusters/2020-22/02published on 08.12.2020) for contractual engagement of 10 State Programme Coordinators (SC-1, ST-1, OBC-3 & UR-5), 250 Young Fellows (SC-38, ST-19, OBC-68 & UR-125) and 250 Cluster Level Resource Persons (SC-38, ST-19, OBC-68 & UR-125) to work in its Project for Creating Model GP Clusters across India.

The requirements as regards job description, required competencies, consolidated contractual remuneration for the positions of State Programme Coordinators, Young Fellows and Cluster Level Resource Persons, provisions for reservation and relaxation of age etc. were mentioned indetail in the Notification mentioned above.

Now, in view of a subsequent decision taken by the competent authority, NIRD&PR invites online applications further from eligible EWS candidates (1 post for State Programme Coordinator, 25 posts for Young Fellows & 25 posts for Cluster Level Resource Persons) and PwD candidates (1 post for State Programme Coordinator, 10 posts for Young Fellows & 10 posts for Cluster Level Resource Persons). Age relaxation as per government rules will be applicable to candidates from PwD category.
