The application routed through proper channel should accompany ACRs of last 5 years. Vigilance clearance certificate and copies of testimonials should also be furnished.
- 3. The persons with the Degree of Disability of minimum 40% are eligible for applying for the posts earmarked for PWD Category. Wherever posts which are earmarked suitable for PWD category but no vacancy exist in that particular category of disability; candidate will not be considered for any relaxation/ concession at any stage of recruitment.
