**SPECIAL RECRUITMENT - DISTRICT-WISE**

Applications are invited from qualified **Scheduled Caste and Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after one time registration. Candidates who have already registered can apply through their profile.

- 1 **Name of Department** : **Health Services**
- 2 **Name of** : Staff Nurse Gr II (Special Recruitment for SC/ST )
- 3 **Scale of pay** : ₹ 27800-59400
- 4 **No. of Vacancy** : **Districtwise**  
**KANNUR- 1 (SC/ST)**

**Note:(i)** *The above vacancy is now in existence. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled castes / Scheduled Tribes during the currency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.*

**Note:(ii)** *The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special conditions laid down in G.O (MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she complete five (5) years continuous service from the date of commencement of service in the former District. Even if, transfer is allowed after five (5) years, it will be subject to the orders contained in G.O(Ms)No.4/61/PD dated 2.1.1961. Candidates already in Government service, holding the post in any one District are restricted from applying for the same post in another District. But they can apply for higher posts when notified.*

**Note:(iii)** *Candidates from the Ranked List for district wise selection will be advised for appointment against the Headquarters vacancies also. As per the provision in G.O(Ms) 154/71/PD dated 27.05.1971 appointments against the Headquarters vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.*

**5 Method of Appointment** : Direct Recruitment  
(Special Recruitment from among Scheduled Caste & Scheduled Tribes only).

**Note:-** *Applications received from candidates other than Scheduled Caste & Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.*

**6 Age** : 20-41,  
Only Candidates born between 02.01.1980 and 01.01.2001 (both dates included) are eligible to apply for this post.

**Note :** *In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.*

**7 Qualifications:**

(i) A Pass in Plus Two/Pre-Degree ( with Science Subjects) Course/Pass in VHSE ( with Science subjects)/VHSE in Domestic Nursing of a recognized University or its equivalent.

(ii) A Pass in B.Sc Nursing of recognized University or a pass in General Nursing and Midwifery Course having not less than 3 years duration from any institution recognized by Government.

(iii) Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and Midwife, in the case of woman candidates and as Nurse in the case of Male candidates.

**Note :** 1. Rule 10(a)(ii) of part II of KS&SSR is applicable

2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

4. Candidates who have claimed bogus information about qualification and Experience in application irrespective of whether they attend the exam after giving confirmation will be subject to disciplinary action as per Rule 22 of KPSC Rules of procedure 1976.

**8 Method of Submitting application:**

(a) Candidates must register as per ONE TIME REGISTRATION with the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, community etc. have to be produced as and when called for.

(b) **Candidates who have Aadhaar card should add Aadhaar card as I.D proof in their profile.**

**11** If a Written / OMR / Online Test is conducted as part of this selection, Candidates shall submit a confirmation for writing the examination through their One Time Registration profile. confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission tickets will be published in the Examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- 12** Paragraphs two, three and twenty five (except the conditions laid down in Rule 3 (c), Part II of the Kerala State and Subordinate Service Rules) are not applicable to this selection.
- 13** Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O(Ms) 142/72/PD dated,13.04.1972,G.O(Ms) 309/73/PD dated,29.11.1973, G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled caste /Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
