TGT (HINDI) MALE, POST CODE-140/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 271 [UR-143, OBC-87, SC-24, ST-17, including PH (OH-04, VH-04)] vacancies for the post of **TGT (Hindi) Male, Post Code-140/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on 28/08/2018.

2. On the basis of online examination of Tier-1 held on 28.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT (Hindi) Male, Post Code-141/17** in Directorate of Education, a total of **226 (UR-137, OBC-48, SC-24, ST-17 including UR/OH-01, SC/OH-01, UR/VH-04)** candidates were provisionally nominated for the post of **TGT (Hindi) Male, Post Code-140/17** vide Result Notice No. 439 dated 22.05.2019 and the candidature of **11 candidates** (UR-06, OBC-05, including UR/PH/OH-02) was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. 25.05.2019 to 03.06.2019. Further, **13 candidates** under OBC category were kept pending for verification of their OBC (Delhi) status. Thereafter, **21 candidates (UR-04 including 02 PH, OBC-17)** were nominated vide **Supplementary Result Notice No. 522 dated 01.10.2019.**

3. Now, the User Department vide letter dated 27/12/2019 has returned the dossiers of 19 candidates (UR-17, OBC-01, SC-01) after cancellation of their candidature due to not accepting of offer of appointment. Accordingly, 19 vacancies under (UR-17, OBC-01, SC-01) have been vacant. Therefore, the candidature of eligible candidates in waiting panel is being taken into consideration for nomination in their respective categories.

4. Accordingly, in continuation to **Result Notice No. 439 dated 22.05.2019 & Supplementary Result Notice No. 522 dated 01/10/2019**, the candidates, as detailed below, are also provisionally selected on the basis of online computer bases examination of Tier-1 held on 28.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT (Hindi) Male, Post Code-140/17** in Directorate of Education.

5. The selection of the above 18 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.



9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide **MHA O.M. No. 2/29/54-RPS, 19-11-54.**

10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

11. The candidature of the following candidates have been kept pending for want of deficient / requisite documents in the e-dossier.

12. The result process for the above post code stands closed in all respect except 02 vacancies for Roll No. 120214000376, 111014000383) which have been kept pending for want of deficient documents in the e-dossier.

13. A waiting panel under UR/SC/ST category was prepared which has been expired on 21.05.2020 as per earlier result notice no. 439 dated 22.05.2019.


14. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
