## SUPPLEMENTARY RESULT NOTICE NO. 884 DATED 01/07/2022 SPECIAL EDUCATOR, POST CODE-15/17 IN MUNICIPAL CORPORATION OF DELHI

The Hon'ble High Court of Delhi in W.P(C) No. 9040/2019 read with CM No. 22861/2020 & CM No. 25471/2020 in the matter of Praveen Kharti & Ors vs GNCTD has pronounced its judgment vide order dated 27.10.2021 vide which Hon'ble High Court has granted relief to Petitioner No. 4 to 6 of W.P(C) No. 9040/2019 read with CM No. 22861/2020 as well as Petitioner of CM No. 25471/2020 and directed to extend the one time relaxation of CTET in post code 15/17 duly approved by Hon'ble LG to these petitioners also.

- 2. The operative para's in W.P. (C) No. 9040/2019 read with CM No. 22861/2020 & C.M No 25471/2020 are as under:-
  - 2.4 Mrs. Avnish Ahlawat, who appears on behalf of respondent no. 1/GNCTD, cannot but accept the fact that the appointment offer(s) have been made in respect of persons, who submitted their CTET certificates, after the cut-off date provided in the aforementioned advertisement, but before the date of appointment.
  - 3. That being the positions we are of the opinion that, merely because the CTET qualification was obtained after the cut off date, but before the completion of the recruitment process, persons represented by Mr Naagar, cannot be treated differently.
  - 4. In these circumstances, we are of the view that the order dated 13.03.2020 granting relaxation, inter alia, qua CTET qualification, as regards the subject post, issued by the Director of Local Bodies, Government of NCT of Delhi with the approval of the Lieutenant Governor, should be extended to persons represented by Mr Naagar i.e, petitioner nos. 4 to 6 and the applicants in CM No. 25471/2020.

- 3. The DSSSB, vide its advertisement No. 02/2017 dated 07/08/2017 had advertised 1540 posts (UR-773, OBC- 426, SC-226, ST-115(including PH/OH-24 & PH/VH-25) for the post of Special Educator under post Code -15/17 in MCD with closing date as 15.09.2017. Examination to the above post code was held on 22.07.2018.
- 4. On the Basis of exam shortlisted candidate were called for uploading of document in E-dossier module w.e.f. 17.09.2018 to 26.09.2018 vide notice dated 13.9.2018. On scrutiny of the Dossier uploaded in support of educational qualification, age etc in accordance with advertisement No. 02/2017 and RRs for the post of Special Educator, Post code -15/17 in MCD, a total of 445 (UR-281, OBC-47, SC-105, ST-12 including PH-20) were provisionally nominated vide result notice No. 354 dated 25.02.2019, Supplementary Result notice no. 479 dated 12.07.2019.
- 5. Subsequently on the direction of the Hon'ble High Court in W.P(C) No. 9040/2019 titled as Praveen Khatri & Ors Vs GNCTD & Ors, the user department i.e., had got the approval of Hon'ble Lt. Governor of Delhi through Director (Local Bodies), Delhi Secretariat, GNCTD to grant relaxation as per the power conferred in Clause 5 of RR to the Post of Special Educator (Primary) in Municipal Corporation of Delhi in the following matters:-
  - 1. To consider the CTET qualification of the candidates who are otherwise qualified and obtained the CTET qualification after the cut off date but before their appointment to the post of Special Educator (Primary) under post code15/17.
  - 2. To relax the age of candidates who are otherwise qualified for appointment to the post of Special Educator (Primary) under post code 15/17.

In this regard, Hon'ble Lt. Governor, Delhi has granted one time relaxation of age and CTET qualification to the otherwise qualified candidates who have obtained the CTET qualifications after the cutoff date but before their appointment and age relaxation even if they may have become overage for the post of Special Educator (Primary) as advertised vide post code no.15/17.

Further, grant of age relaxation to the candidates, otherwise eligible, has been considered on same lines as done by Education Department, GNCTD recently for Special Education Teachers vide order has been considered vide No. F. 209/DDE (IEDSS)/Court File/2016-17/CD No. 043457883/9831-37 dated 06.12.2019.

This shall not be treated as precedent for any future recruitment for the post or any other posts.

The Office Order in this regard has been issued by Dy. Director (Local Bodies vide No. F. CD No. 000583201/18194-18198 dated 13.03.2020....."

- 6. Accordingly, 08 candidates (including 01-UR, 03-OBC, 02-SC, 02-ST) were provisionally nominated vide Supplementary Result Notice No. 662 dated 04.09.2020 and 46 candidates (including UR-30 (incl. 01-VH), OBC-08, SC-04(incl. 01-OH), ST-04) were nominated vide Result Notice No. 701 dated 07.01.2020. Further, 01 SC category candidate was provisionally nominated vide Result Notice No. 742 dated 12.01.2021 by giving relaxation in age and CTET after cut off date.
  - 7. Now, in compliance of the directions of the Hon'ble High Court order dated 27.10.2021 in W.P(C) No. 9040/2019 read with CM No. 22861/2020 and CM No. 25471/2020 titled as Praveen Khatri & Ors vs. GNCTD as well as in compliance of one time age/CTET relaxation in post code 15/17 as granted by the user department i.e, MCD through Director (Local Bodies) duly approval by Hon'ble LG of Delhi, the candidature of 05 court case candidates as per detail mentioned below is revived by rescinding the Rejection Notice No. 475 dated 12.07.2019 in respect of 05 petitioners only in CM No. 22861/2020 and CM No. 25471/2020 of W.P(C) No. 9040/2019 and provisionally nominated for the post of Special Educator, Post Code -15/17 subject to outcome of SLP petition filed (vide diary no. 15067 dated 11.05.2022) before the Hon'ble Supreme Court of India.

- 8. The selection of the above 05 candidates (UR-04 and SC-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 9. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the

- candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed OBC (Delhi) certificate as specified entitlement of Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 11. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 13. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- **14.** The result process for the above post code stands closed in all respect.
- 15. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

**16.** The category wise marks obtained by the last selected candidates have been given as under:-
