### NOTICE

**Subject:- Declaration of Marks of Online examination held on 28.06.2021 for the Post of PGT (Commerce), Male, Post Code-23/20 and uploading e-dossier – regarding.**

The DSSSB vide advertisement No. 02/2020 had advertised **61 vacancies (EWS-02, UR-27, OBC-16, SC-10, ST-06 including PH/OH-02, PH/VH-02)** for the post of PGT (Commerce) Male, Post Code-23/20 in Directorate of Education.

2. Tier-I online written examination was held on 28.06.2021.

3. The marks obtained by **1555 candidates** who duly appeared in written examination conducted (**online mode**) on **28.06.2021** have been uploaded on the OARS module of the Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dsssbonline.nic.in](http://www.dsssbonline.nic.in).

4. Based on the performance in the examination (online mode), **a total of 627 candidates** have obtained marks above or equal to minimum qualifying marks in their respective categories out of which 150 candidates as per their merit have been provisionally shortlisted to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in their online application forms.

5. The cutoff marks for uploading of e-dossiers only have been given as under:-

**Note:-** The candidates may also refer para 2 (Mode of Selection) (Examination Scheme) of advertisement No. 02/2020 that :- If there are two or more candidates in the same category having equal marks in the examination:

i. **In case of One/Two Tier Technical Posts:-**

- Candidate securing more marks in subject specific section is to be placed higher in merit;
- In case where the marks mentioned at (a) above are also equal, the candidate senior in age is to be placed higher in merit.
- In case where the dates of birth are also the same, the candidate whose first name comes first in Alphabetical order (in English) is to be placed higher in merit.

**i. In case of Non-technical / General Posts:-**

- (a) Candidate senior in age is to be placed higher in merit.  
(b) In case where the dates of birth are also the same, the candidate whose first name comes first in Alphabetical order (in English) is to be placed higher in merit.

**6. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the relevant documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/1<sup>st</sup> page of Admit Cards duly signed by the invigilator at the examination centre etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I written examination for 300 marks.**

7. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.

8. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time.

**9. The e-dossier link shall be activated for a period of 15 days w.e.f. 08/09/2021 to 22/09/2021.**

10. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **13/02/2020** as per Advertisement No. 02/2020. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. **as an additional facility** just for the facilitation of the candidates. But in case a candidate does not get any information on his/her registered mobile no./email id due to any reason, then it would not give any right to the candidate for extension of uploading of e-dossier. **Therefore, if, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.**

11. Candidates are advised to visit website of the Board and OARS portal regularly for further information.

12. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. **It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.**

13. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

14. The above short listing of candidates for calling of e-dossier for the post of **PGT (Commerce), Male, Post Code-23/20 in Directorate of Education** is subject to outcome of pending court case, if any.
