Note 4: Relaxation of age will be considered in respect of Ex-servicemen and PWD candidates as per the DOPT guidelines in addition to the other relaxations like community and sports persons.

Note 5: Reservation Rule is only for claiming age relaxation in Sports Recruitment. Such candidates should necessarily submit proof of age i.e., SSC Certificate and Caste Certificate for claiming age relaxation.

Note 6: The concession will be available only to those sportspersons who satisfy all other eligibility conditions relating to educational qualifications etc. and furnish a certificate in the form from an authority prescribed in these instructions.

Note 7: No appointment can be made unless the candidate is, in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of category of persons to which the applicant belongs.

Note 8: Explanation: An Ex-Serviceman means a person who fulfills all terms & conditions as laid down in Department of Personnel & Training, New Delhi O.M. #### Educational and other Qualifications (as on last date of receipt of application): 6.

#### 6.1 Postal Assistant/SortingAssistant:

- The candidates must have passed 12th Standard or equivalent examination from a i. recognized university or Board of School Education or Board of Secondary Education.
- In case of the candidate possessing equivalent educational qualification, such candidates ii. shall also produce relevant equivalence certificate from the concerned authorities at the time of submission of the documents. However, the final decision regarding selection of such candidates will be taken by the concerned User Departments/Appointing Authorities.
- The candidates of higher qualifications will also be considered but they have to fulfill iii. the above conditions. There are no bonus marks for higher education.
- The candidates will be required to furnish certificate of Basic Computer Training (at iv. least 60 days duration) from a recognized Computer training institute before issuance of appointment letter. Computer Training Certificates from Central Government/State Government/University/Boards etc. will also be acceptable for the purpose. This requirement of Basic Computer Knowledge Certificate is relaxable in cases where a candidate has studied computer as a subject in matriculation or Class XII or Higher educational qualification and in such cases a separate certificate will not be insisted

#### 6.2 Postman:

The candidates must have passed 12th Standard or equivalent examination from a i. recognized university or Board of School Education or Board of Secondary Education.

Knowledge of local language (i.e. Hindi). The candidate should have studied local ii.

language (i.e. Hindi) at least up to 10th standard.

The person appointed to the post of postman shall acquire a driving license to drive iii. two wheeler or three wheeler or light motor vehicles within a period of two years from the date of his appointment. However, the person with disability shall be exempted from the requirement of driving license.

The candidates will be required to furnish certificate of Basic Computer Training from iv. a recognized Computer training institute before issuance of appointment letter. Central Government/State Certificates from Training Computer Government/University/Boards etc. will also be acceptable for the purpose. This requirement of Basic Computer Knowledge Certificate is relaxable in cases where a candidate has studied computer as a subject in matriculation or Class XII or Higher educational qualification and in such cases a separate certificate will not be insisted

The candidate not having valid driving licence at the time of appointment shall not v. earn periodical increment in pay till production of such licence or for a period of five years from the date of appointment whichever is earlier and after production of such licence or expiry of such five years period, pay shall be restored prospectively to the level pay would have reached as if periodical increment in pay was not withheld and

#### 6.3 Multi Tasking Staff:

- The candidate must have passed 10<sup>th</sup> Standard from a recognized Board of School Education or Board of Secondary Education.
- ii. Knowledge of local language (i.e. Hindi). The candidate should have studied local language (i.e. Hindi) at least up to 10<sup>th</sup> standard.
- iii. The candidate should have Knowledge of working of computer.
- iv. The candidates of higher qualifications will also be considered but they have to fulfil the above conditions. There will be no preference for higher educational qualifications.
- v. Sports qualification as per para 7 of the notification.

#### Note in respect of educational Qualifications:

- i. As per Ministry of Human Resource Development Notification dated 10.06.2015 published in Gazette of India, all the degrees / diplomas / certificates awarded through Open and Distance Learning mode of education by the Universities established by an Act of Parliament or State Legislature, Institutions Deemed to be Universities under Section-3 of the University Grant Commission Act, 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services under the Central Government provided they have been approved by the University Gtants Commission.
- ii. Candidates must possess essential educational qualification from recognized Board/University before applying for the posts.
- iii. Candidates have to submit a self-attested copy of original certificates.
- iv. Applicants having both marks and Grades in the mark list shall enter the marks only. If any applicant applies with Grades his application will be liable for disqualification.
- v. Applicants having only the Grades / Points in the marks list shall note the Grades in respective column. The marks will be reckoned by taking conversion of Grades/Points with the multiplication factor (9.5) against the maximum points or Grade as 100.

#### 7. Sports Eligibility (as on the last date of receipt of application):

Appointments will be made of sports persons considered meritorious with reference to the following criteria:

- a) Sportsmen who have represented State or the country in the National or International competition in any of the games/sports listed in Para 8.
- b) Sportsmen who have represented their university in the Inter-university Tournaments conducted by the Inter-University Sports Boards in any of the sports/games listed in Para 8
- c) Sportsmen who have represented the State School Teams in the National Sports/games for schools conducted by the All India School Games Federation in games/sports listed in para 8.
- d) Sportsmen who have been awarded National Awards in Physical Efficiency under the National Physical Efficiency Drive listed in Para 8.

#### 10. Method of Selection:

Selection of the candidates will be made on educational and Sports qualification subject to fulfilment of prescribed conditions.

The main aim to recruit outstanding sportspersons is to prepare a best team of sports persons, which may bring laurels to the Circle in All India and other competitions apart from their best performance in official duty. In view, the most suitable and fit candidates will be considered. Selected candidates will have compulsory participation in the Circle team during All India Postal tournaments for specified years by the department.

Meritorious Sports Candidates will be selected for appointment based on the instructions contained in the Department of Personnel and Training OM No. 14015/1/76-ESTT (D) dated 04-08-1980 and as amended from time to time and consolidated instructions issued by DOPT OM No. 14034/01/2013-ESTT (D) dated 03-10-2013 and Postal Directorate, Department of Posts, New Delhi letter No. 17-07/2017-SPN-I (Pt.) dated 06.01.2021.

#### Order of preferences:

- a) First preference: Candidates who have represented the country in an International Competition with the clearance of the Department of Youth Affairs and Sports.
- b) Seco. preference: Candidates who have represented a State/ Union Territory in the SENIOR OR JUNIOR LEVEL NATIONAL CHAMPIONSHIP organized by the National Sports Federation recognized by Department of Youth Affairs and Sports or National Games organized by Indian Olympics Association and have won medals or position up to 3rd place. Between the candidates participating in Senior and Junior National Championships /Games, the candidates having participated and won medals in Senior National Championship will be given preference.
- c) Third preference: Candidates who have represented a University in an INTER UNIVERSITY COMPETITION conducted by Association of Indian Universities/ Inter University Sports Board and have won medals or position upto 3rd place in finals.
- d) Fourth preference: Candidates who have represented the State Schools in the NATIONAL SPORTS/ GAMES FOR SCHOOLS conducted by the All India School/ Games Federation and have won medals or position up to 3<sup>rd</sup> place.
- e) Fifth preference: Candidates who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.
- represented Candidates who have f) Sixth preference: Territory/University /State School Teams at the level mentioned in categories (b) to (d) above, but could not win a medal or position, in the same order of preference.

Note 1: In the event of tie, those who have secured a higher position or won more than one medal will be given the preference.

- b) In case of tie in the date of birth, first name of the applicant in alphabetical order.
- Note 2: Participation in individual and team event/item will be given the same preference.

Note 3: No preference will be given for winning more than one medal/position.

- Note 4:Decision of the competent authority i.e. The Chief Postmaster General Chhattisgarh Circle will be final.
- Division/unit allotment criteria: The criterion for allocation of cadre and Division/unit is as 11. under:
  - a) A candidate will be allocated the cadre and Division/unit on the basis of her/his merit, order of preference of Division/unit and vacancy available in Division/unit at her/his turn.
  - b) Person with disability (PWD) candidates irrespectively of their ranks will be allocated first followed by the candidates of other category as per the vacancy available.
  - c) After allocation of cadres and divisions to PWD candidates, remaining candidates will be allocated cadres and divisions in the manner mentioned in (a) above.
  - d) All such candidates who do not give any order of preference or is not allocated to any of the Division/unit mentioned in the limited preferences will be allocated cadre and Division/unit subject to availability of vacancy in the Division/unit, after allocation of posts to all other candidates.

#### 13. Application fee:

The candidates shall have to pay Application fee of Rs. 100/- (Rs.One hundred only) through e-payment in the name of CPMG CHHATTISGARH (E-Biller ID 70138) at any of the computerized post office in India using Challan Form by 03.12.2021. Fee once paid shall not be refunded. Fee paid through any other mode will not be accepted and such application will be summarily rejected. The last date of receipt of application at O/o Chief Postmaster General Chhattisgarh Circle, Raipur-492001 is 03.12.2021.

#### 14. Procedure for payment of application fee:

- a) Challan form available with the notification may be downloaded from India post website <a href="www.indiapost.gov.in">www.indiapost.gov.in</a> or Chhattisgarh Postal Circle website <a href="www.cgpost.gov.in">www.cgpost.gov.in</a> and fees be paid at any Post Office through e-payment. The Post Office shall retain one copy of Challan form & Candidate will get Chief PMG Chhattisgarh Circle's copy & Candidate's copy.
- b) Original receipt generated by Post Office, should be pasted on application form, while candidate may retain candidate's copy for future reference.

Note: Women/SC/ST candidates are exempted from payment of application fee.

- 16. The copies of the educational qualification certificates, Certificate of Basic Computer Training, Proof of date of birth, Community certificate in respect of SC/ST/OBC/EWS/PH, Proof in respect of Sports qualification/achievement, copy of Driving License of two wheeler or Light motor vehicle in case of Postman cadre and any other document required for the recruitment, duly self-attested and original Challan should be sent along with the filled application.

#### 17 Special Instructions to the Applicants:

a) Incomplete application/misrepresentation of facts/unsigned application/form without photographs /without prescribed application fee/not accompanied by attested copies required certificates/late receipt of application/application without original copy of Challan meant for CPMG/application wrongly addressed will be rejected. No correspondence will be done in this regard.

b) Candidate applying for more than one game/event shall submit separate application form along with requisite fee and with complete documents for each game/event in separate envelope/cover and all such envelopes/covers are also to be sent through Speed Post only.

c) If it is proved at any stage that the candidate has forwarded incorrect or false information, candidate will be disqualified.

- d) One envelope should contain application form of only one candidate for single sports discipline. Application forms of any candidate for more than one sports discipline submitted in a single envelope/cover or application form of more than one candidate received in a single envelope will be summarily rejected.
- e) Application received by any other means other than Speed Post shall be rejected straightway.
- f) Original certificates should not be submitted. Copies of all the required documents and certificates duly self-attested should be sent along with the application form. The documents/marks list/certificates submitted at a later date will not be entertained.
- g) The candidate should have educational certificate issued on or before the last date of receipt of application and he/she have to produce the original documents such as mark sheet, provisional certificates etc. as proof of having acquired the minimum educational qualification at the time of submission of the documents in Department failing which the candidature of such candidates will be cancelled by the Department.
- h) Application received without proof of date of birth will be rejected straightway.
- i) Do not staple photograph on application, paste one recent self-attested passport size photograph on application at the prescribed space & sign across the photograph in such a way that the half of the signature should be on application form and half on pasted photograph. Applications without photograph, without across signatures will be summarily rejected.
- j) Community certificate for SC/ST/OBC/EWS in the prescribed form issued from the competent authority as in <u>Annexure II to IV</u> is to be submitted. Certificate submitted in any other form or from authorities not competent to issue such certificate will not be accepted. In case of EWS candidates, application received without EWS certificate will be straightway rejected.
- m) The Department reserves the right either to revise the number of vacancies or to cancel the recruitment, if so warranted and the Department will not be liable to return the fee or any other compensation on the applicant's application.
- n) No correspondence in person, e-mail, telephone etc. will be entertained.
- o) The selected candidates are liable to serve anywhere in Chhattisgarh Circle as and when required at the sole discretion of the appointing authority.
- p) Selected candidates shall be required to give an undertaking to the effect that they shall not apply for inter-change transfer before rendering regular service for a minimum period of 2(two) years.
- q) Selection of candidates will be made in accordance with the relevant recruitment rules and administrative instructions issued by the Department of Posts from time to time.
- r) Applicant who claims change in name after matriculation on marriage or re-marriage or divorce etc. the following documents shall be submitted.

- s) All relevant documents and certificates will be required to be produced in original at the time of appointment.

#### 18. Nationality / Citizenship:

Applicant must be either,

- a) a citizen of India, or
- b) a subject of Nepal, or
- c) a subject of Bhutan, or
- d) a Tibetan refugee who came over to India, before the 1st January, 1962 with the intention of permanently settling in India.
- e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.

Provided that Applicant belonging to categories (b), (c), (d) and (e) above shall be a person in whose favor a certificate of eligibility has been issued by the Government of India.

#### 19 Disqualification:

- Person who has entered into or contracted a marriage with a person having a spouse living;
   or
- ii. Person who, having a spouse living has entered into or contracted a marriage with any person shall not be eligible for appointment to the said posts provided that:

The Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

#### 20. Disclaimer:

- Success in the proficiency in the game/ground (field trail) confers no right to appointment unless Department is satisfied after such enquiry, as may be considered necessary, that the candidate is suitable in all respect for appointment to the post.
