



- So far, banking ombudsmen were allowed to impose a fine of *Rs10 lakh* on banks for mis-selling.

- The Mahabodhi Temple Complex, Bodh Gaya lies 115 km south of the state capital of **Bihar**, Patna and 16 km from the district headquarters at Gaya, in Eastern India.

- In June 2002, the Mahabodhi Temple became a UNESCO World Heritage Site.
