FOR CANDIDATES APPEARED FOR CBT
CEN No. RRC- 01/2019 (Level-1 posts)
(Recruitment for various posts in Level-1 of 7th CPC Matrix)

1. The Computer Based Test (CBT) results for Level 1 posts notified against CEN RRC 01/2019 conducted from 17.08.2022 to 11.10.2022 in various phases by RRBs is likely to be declared around 24.12.2022.
2. All the candidates who have opted for South Central Railway and expecting to be qualified in CBT are advised that, the **Physical Efficiency Test (PET) is planned which is likely to be conducted for the shortlisted candidates from 12.01.2023**. Hence, all the candidates are advised to practice the events and be ready for the PET at a short notice of 07-10 days, for which communication will be sent by SMS & E-mail.
3. Based on the merit of the candidates in the CBT, candidates shall be called for PET Three times the community wise total vacancy of the Posts notified against RRBs/RRCs. However, Railways reserve the right to increase/decrease this ratio as required to ensure availability of adequate/reasonable number of candidates for all the notified posts. Passing Physical Efficiency Test (PET) is mandatory and the same will be qualifying in nature. The criterion for PET is as under:

Male candidates	Female / Transgender candidates
Should be able to lift and carry 35 Kg of weight for a distance of 100 metres in 2 minutes in one chance without putting the weight down; and	Should be able to lift and carry 20 Kg of weight for a distance of 100 metres in 2 minutes in one chance without putting the weight down; and
Should be able to run for a distance of 1000 metres in 4 minutes and 15 seconds in one chance.	Should be able to run for a distance of 1000 metres in 5 minutes and 40 seconds in one chance.

4. **The Persons with Benchmark Disabilities (PwBD) and Course Completed Act Apprenticeship (CCAAs) are exempted from appearing for PET.**
5. Beware of Touts and job racketeers trying to deceive by false promises of securing job in Railways either through influence or by use of unfair and unethical means. RRB/RRC never appoints any agent(s) or coaching center(s) for action on its behalf. Candidates are warned against any such claims being made by persons/agencies. Candidates are selected purely as per merit. Beware of unscrupulous elements and do not fall in their trap. Candidates attempting to influence RRB/RRC directly or indirectly shall be disqualified and legal action can be initiated against them.
6. Candidates are advised to visit only the official website of RRBs/RRCs and beware of FAKE websites and social media content put up by unscrupulous elements/touts.
